## Minutes of General Body Meeting of CRWA held on 21/12/2019

A meeting of the General Body of the Cosmopolis Residents welfare Association (CRWA) was held at 7 PM on 21-12-2019 which was presided over by the President, CRWA Mr. Ratnakar Baral. 48 Members and Associate Member signatories were present in the meeting.

1. The President welcomed all the esteemed members and drew their attention to the developments relating to the resolution of the GB in its emergency meeting vide para 8 and the follow up action of the Governing Body/EB in issuing show cause notices to them and their responses there to. He informed the GB that all of them had responded in time to the notices served on them
2. Mr Arun Mohanty in his reply denied all allegation against him as false and has also assured in his reply that he would not give any chance to the EB to make any further allegation against him touching the affairs of the society. Mrs Abha Mohanty w/o Mr Arun Mohanty and Co-owner of flat no G-161 also responded in writing & stated that the behaviour of Mr Arun Mohanty was unintentional and situational and assured that she would make him understand and this situation would not occur in future
3. Mr Siddhartha in his reply stated that his utterings in the EGB was due to emotional stress and apologized for using such words as 'kangaroo court'. He also desired to maintain peaceful relation with all residents & promised that he would not do anything against the interest of the society
4. In case of Mr Ramahari Padhy, the President informed the G.B that on the same issue Mr. Ramahari Padhy had filed a case vide civil Suit No-2183 of 2019 in the court of Honorable civil Judge (Senior Division), Bhubaneswar against President , General Secretary & Joint Secretary of

CRWA challenging the MOM of the EGB dt 8/12/19 and the follow up action by Governing Body and the EB for its execution. He also informed that the Hon'ble court has restrained the President ,General Secretary & Joint secretary representing CRWA from stopping any facilities to the petitioner as per the minutes dt 8/12/2019 and notice dated 13/12/19 till 13/01/2020, the date to which the case is posted for next hearing. Since Mr Padhy had challenged the decision of the GB and made the President, Gen.Secretary & Joint Secretary of the CRWA as respondents, the Governing Body in its meeting held earlier on that day has unanimously approved and authorised the three respondents to legally respond to the case

5. The President ,CRWA further informed the GB that the Governing Body /EB in its meeting held earlier had unanimously recommended to drop all charges against Mr. Siddhartha Sahu & Mr.Arun Mohanty and revoke the order of ex-communication .The Governing body and the EB also wanted similar recommendation /action in case of Mr.Ramahari Padhy but could not do so as the case is subjudice and the respondents have to legally respond to the court case.
6. After due deliberation on of their responses, the General Body unanimously accepted the recommendation of EB/Governing Body, revoked the order of ex-communication and dropped all charges against Mr.Sidharth Sahu Flat No-H-122 & Mr Arun Mohanty Flat No-G-161 in the spirit of forget and forgive.
7. Since Mr. Ramahari Padhy's case was subjudice, the Governing body could not recommended any other measure other than legally responding to the court case although the EB/Governing body sincerely wanted to put an end to the whole episode in the larger interest of the society
8. At this juncture, some of the members of the General Body tried to convince Mr.Ramahari Padhy who was present in the GB to withdraw the court case and amicably settle the matter. Mr Ramahari Padhy explained the situation under which he approached the court and after pursuation by some members, that it was in the best interest of all he agreed to withdraw the case. It was agreed that all actions contemplated

against Mr.Ramahari Padhy would be dropped subject to withdrawal of court case by Mr Ramahari Padhy

9. The President informed the GB that the Associate members (Tenants), CRW against whom action was also initiated have submitted their written responses. In their written statement, they have stated that they sincerely regret & felt extremely sorry if their conduct had hurt sentiments of some senior people/owners. They also requested GB to forget and forgive & withdraw any action contemplated against them. Some members(Tenants)also spoke in the GB meeting and assured that they were very much part of the society and would always work for the betterment of the society along with other residents
10. At the end, after examining all responses, and taking into account the recommendations of the EB/Governing Body ,the General Body decided as follows:-

- (1) The decision regarding ex-communication as per 8(l) of the MOM of EGB dt 8/12/19 is revoked with immediate effect.
- (2) All actions contemplated against Mr Siddhartha Sahu Flat No H-122 & Mr Arun Mohanty Flat No G-161 are dropped.
- (3) All actions contemplated against Mr.Ramahari Padhy Flat No J-034 is dropped subject to withdrawal of civil suit no.2183 dt 19/12/19 filed by Mr Ramahari Padhy in the Honourable court of civil Judge (SD), Bhubaneswar
- (4) All actions contemplated against the tenants are dropped. The EB was asked to inform the owners accordingly
- (5) The EB should not be dragged to resolve personal quarrels/conflicts between children or adults which may be resolved by the senior members/ladies club of the society as the case may be.
