

Emergency General Body Meeting on 02.02.2020

As per the representation of more than 30 members/owner, an emergency meeting of the General Body of the CRWA was held at 06.00PM on 02.02.2020 56 member signatories were present in the meeting and President, CRWA presided over it.

1. Agenda No.1 "Settlement of Book of Accounts" for the period from 01-01-2019 to 31.08.2019 by the last Executive Body the G.S apprised the G.B of the developments so far on the issue citing the decision/outcome of the joint meeting of the Governing Body, Audit Committee, legal Committee and the last E.B held on 23.01.2020. He informed the august Body that the matter has not yet been settled for which he may face problem in filing the I.T returns for the FY 2019-20 of the Socieity. He urged the Last E.B to settle the Books Of Accounts with supporting documents like vouchers, bills, challans, cheques and receipts as available with them/CRWA office and rectify the mismatch in the data in tally of their tenure.

Mr. Pruthijit Mohanty, the Treasurer of the last E.B made his point on the matter and said that the information as required has already been given to the GS, CRWA. The G.S, CRWA contested his claim to this. Mr. Mohanty said that he was prepared to furnish further information/statement as per requirements of the present E.B in their prescribed format of Account settlement for the aforesaid period provided he is allowed to have access to all those records and permission to use the office and the office staff for such settlement. To resolve the impasse & for timely completion & handing over of accounts etc, the G.B unanimously constituted a committee to look into all aspects, complete the reconciliation & submit a report by 15/02/2020.

2- On Agenda No.2 "Unruly Behaviour of Mr Ramahari Padhy" the President announced from the outset that the E.B with due regards to the decision No-10(5) of the G.B taken in its meeting held on 21.12.2019 , did not want to be dragged to such issues, It was up to the General Body to examine whether the issue is individual issue or community issue. Then Mr Saroj Kumar Samantaray drew the attention of the G.B about an unpleasant incident that took place at about 9.30PM on 22 January when Mr. Ramahari Padhy used unparliamentary and vulgar language at him when he was moving with his family (wife & daughter), The action of Mr. Padhy was deliberate and quite intentional. It was quite humiliating for a respectful resident of the society. Thereafter there was a heated argument between Mr. Samantaray & Some members on one side & Mrs & Mr Ramahari Padhy on the other. Seeing the situation was taking an ugly turn & the involvement of the lady wife of Mr. Ramahari padhy the GB abruptly stopped further discussion & members started dispersing.

At the end on request by some members and with permission from the General Body, The G.S read out the names of the member signatories who had made the requisition for such an Emergency General Body Meeting. The General Secretary informed to the G.B that under such disturbing and unpleasant situation, it is very difficult to pay detailed attention to all aspects of maintenance work. As such if anything seriously goes wrong, the EB should not be held responsible.
